Captains Committee Vacancies

There are **two** vacancies available on the Captain's Committee at this year's A.G.M.

After three years Norman Evans will step down from the Captain's Committee at the AGM having served his term of office. We would like to thank 'Satnav' as he is sometimes known, for all of the hours and hard work he has put in. Norman has been a single figure handicapper for six decades, no doubt he will get better still practising instead of attending meetings!

The Committee invites members of more than two years standing to apply through the office to take over the role that Norman has been fulfilling. The role will involve amongst other things -

- * responsibility for the men's golfing calendar and competitions
- * helping to introduce the World Handicapping System
- * being one of the three people on the handicap committee
- * involvement in selection and running of teams for county competitions and friendlies, including mixed events
- * reporting on men's results monthly.



There is an additional Captains Committee Vacancy following the resignation of Josh Greenaway in 2019. The position was co-opted by the Committee to Mrs Maria Buckley until the date of the following A.G.M.

Maria has taken over Junior Liaison duties amongst other responsibilities in this role.

Any member wishing to stand for either of these vacancies must deliver a brief C.V. (maximum 200 words) along with a nomination proposed and seconded by two Full Members in writing in accordance with Club rule 39, to the General Manager not less than 7 days before the Annual General Meeting to be held on Saturday 11th April 2020.

The Management Committee have nominated Mrs Maria Buckley as their candidate for one of the vacant positions on the Captains Committee.

Management Committee Vacancy

There is **one** Management Committee vacancy available There is one MC vacancy available as a result of Martin Biddle (originally an Elected Member) becoming Chairman in July 2019. The position was co-opted by the Committee to Mr Ian Day until the date of the following A.G.M.

The Management Committee have nominated Ian Day as their candidate at the A.G.M.

Any member wishing to stand for the vacancy must deliver a brief C.V. (maximum 200 words) along with a nomination proposed and seconded by two Full Members in writing in accordance with Club rule 39, to the General Manager not less than 7 days before the Annual General Meeting to be held on Saturday 11th April 2020.

Rule 39

Election to Committees

39. The Management Committee shall nominate annually such number of Full Members who may be eligible and willing to act as may be necessary to fill any vacancies in either of the Committees. Any two Full Members may also make any such nominations provided they shall be in writing and delivered to the General Manager not less than seven days before the Annual General Meeting. The names of the candidates so nominated shall be posted on the Club notice board not less than 48 hours before the Annual General Meeting and, if the number exceeds the vacancies to be filled, the election shall be by ballot at the Annual General Meeting. In the event of there being no nominations by Full Members in accordance with this Rule, the nominees of the Management Committee shall be held to have been elected. All candidates shall submit a 200 word short CV to the General Manager seven days prior to the Annual General Meeting for circulation to Members at the meeting and be introduced by the President at the Meeting.
